## *iPad Use Rules*

In the interests of furthering the educational goals of Mother of Providence Regional Catholic School, the school will make available for use by the student one iPad tablet and Google Apps for Education account.

Students and parents are required to review this document, as well as sign the accompanying agreement prior to the use of school issued iPads and Google Apps for Education account.

Technology resources are provided for the purpose of supporting the educational mission of the school. The school's goal in providing the iPad is to promote educational excellence by facilitating resource sharing, innovation, research, creativity, communication, increased productivity, and mobile learning.

Use of these technologies is a privilege that carries responsibility and behavioral expectations consistent with all school rules and policies, including but not limited to those stated in the school handbook. It is understood that all members of the school community will use all types of computing devices and the school's network in a responsible, ethical, and legal manner at all times.

The Archdiocese of Philadelphia, Office of Catholic Education (AOP/OCE), and Mother of Providence Regional School retain sole right of possession of the iPad and related equipment.

The iPad will be issued to students according to the guidelines set forth in this document. AOP/OCE and Mother of Providence Regional School retain the right to collect and/or inspect the iPad at any time, and to alter, add, or delete installed software or hardware.

## *Student Rights & Responsibilities*

### **Use and Ownership**

The iPad is property of Mother of Providence Regional School, and this program is a privilege.

The iPad is for individual student educational use, and will be issued upon the student's and parent/guardian's signed acceptance of the terms of this iPad use agreement.

iPads are not a family device and only should be used by the student and not members of the family.

You will abide by the *Acceptable Use Policy for Technology* and the *Acceptable Use Policy for iPads* guidelines set forth by the Catholic Schools of the Archdiocese of Philadelphia.

If you accept a MPRCS provided iPad, it must be returned to MPRCS at the conclusion of the student's educational relationship with MPRCS or at the conclusion of the school year, whichever is sooner.

Participation in this program will also require participation in the schools Google Apps for Education Program.

### **Technical Support**

Technical support will be provided during normal school hours in the computer lab. Please do not interrupt Mr. Tyrrell when he is teaching another class.

You are responsible for maintaining a backup of all data and settings on the iPad through the use of iCloud.

MPRCS will assist students and parents with setup of an iCloud account for the purposes of file backup.

MPRCS is not responsible for data loss in the event of a device failure or malfunction. Any charges on the student's personal iTunes account are the responsibility of the student.

### **Apps**

The students can sync the iPad to their own household / family iTunes account, install their own apps, music etc.

Students are expected to adhere to the school policies when choosing which apps or songs to install on the school iPad.

The school will charge each student an "app fee". We will use our Volume Purchase Account and purchase the apps for half price. We will then send the student redemption codes for apps we want the students to have. These apps are now property of the student and may be installed on any other iPad / iPod in the student's household.

Parents may opt out of the home syncing option and have the iPad only synced in school. This will be limited only to school applications and will not include music, movies or books.

### **Accidental Damage or Theft Coverage**

The iPad is covered against manufacturer defects by Apple's warranty program. This program does not cover accidental damage, theft or other incidental losses.

If you accept a MPRCS iPad, you have the option of purchasing insurance from the school. Any costs associated with damage or theft of your iPad beyond what is covered by insurance will result in charges to the student and parents.

## **What To Do If Your iPad is damaged or stolen.**

- (1) It is your responsibility to notify the Principal and or Technology teacher immediately.
- (2) In the event of damage or malfunction, make sure you return the iPad and all accessories, even if they are functional, to the computer lab.
- (3) Your iPad will be repaired or replaced at the discretion of the technology staff, and you will be notified of any charges.
- (4) If your iPad is stolen, you will be required to file a police report after notifying the staff in the computer lab.

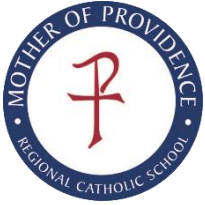
## **Usage**

Your iPad is designed to be your personal learning device. As is the case with all technology used at or owned by MPRCS, you are governed under the rules and regulations covered in MPRCS Acceptable Use Regulations.

Inappropriate use of the iPad could result in the removal of the iPad from your possession and / or additional disciplinary action.

In addition to the Acceptable Use Regulations the following guidelines also apply:

- (1) The iPad may be provided with apps necessary for your school work. You may also purchase additional apps at your own cost. Apps and media purchased on your iPad should be purchased with your personal Apple ID associated with your iTunes account. The apps and media purchased by students remain the student's property.
- (2) MPRCS may purchase apps for student use and give the student a download code for them to redeem under their iTunes account. These apps will remain the student's property.
- (3) Mother of Providence Regional School does use a Proxy Server on the iPads and will be able to filter websites when the student is OFF CAMPUS. In addition Mother of Providence Regional School can view logs of websites visited or attempted to visit websites accessed on a school issued iPad.
- (4) Students may NOT configure additional personal email accounts on the device. Only MPRCS issued email accounts may be used.
- (5) Mobile device management software and profiles may not be removed from the device.
- (6) The student will bring their iPad to school each day with a fully charged battery.
- (7) The student will exercise all due and reasonable care in handling and use of said equipment and agrees to return the equipment in good condition.
- (8) Students can expect their iPad to be periodically inspected and monitored for appropriate usage.
- (9) The iPad or related apps should never be used for purposes for which they were never intended or authorized.
- (10) Only the iPad case issues by MPRCS may be used. No personal iPad cases.
